In 2021, Zirkle and others at MVA worked with the Robinson Bradshaw law firm to form CLIMB (Charlotte Legal Initiative to Mobilize Businesses), a collaborative effort that provides eligible entrepreneurs and small business owners full-service representation on non-litigation business law matters.

In her practice, Zirkle represents a variety of lenders, private equity portfolio companies, and private companies in corporate finance and acquisition transactions.

Zirkle is actively involved with the Law Firm Antiracism Alliance, serving within the organization's Systemic Racism Legal Inventory (SRLI) Banking Working Group, which tackles issues within minority communities and access to capital and banking services.

Zirkle received her J.D. (with honors) from the University of North Carolina at Chapel Hill and her Bachelor of Arts from the University of Tennessee.
